BOARD RESOLUTION No. 2022-005

IMPOSITION OF MEMBERSHIP SANCTIONS IN THE FORM OF FINES BY VIRTUE OF NON-COMPLIANCE ON GENERAL MEMBERSHIP MEETING ATTENDANCE AND CHAPTER ACTIVITY INVOLVEMENT

WHEREAS, the UAP Las Piñas Luntian Chapter, with the guidance of the approved chapter policy, reminded and reiterated the importance of the chapter's mission, vision and core values which are vital on the reaching the goals of the organization;

WHEREAS, after a series of evaluation and consultation, UAP Las Piñas Luntian Chapter ADHOC Committee on Chapter Policy proposed to impose a penalty fine of one hundred pesos (P100.00) on <u>each non-compliant member</u> on attending the Chapter's Monthly General Membership Meeting (GMM) and Chapter activities within <u>each month</u> of the fiscal year.

WHEREAS, the committee based the resolution from the chapter records prepared by the Chapter Secretary. The records showed the list of all the chapter members' attendance highlighting the absences on the Chapter activities and meetings all throughout the current fiscal year;

WHEREAS, other than paying the chapter annual dues and IAPOA fees, the members are expected to participate on chapter programs which has been laid out by the chapter officers. The participation is not limited to attending chapter GMM and going to chapter activities but also on helping the chapter on project documentation and project sponsorship.

WHEREAS, each member of the chapter will be monitored and the non-compliant members will be logged, and communicated after three (3) consecutive months of being inactive. considered inactive and defer the issuance of their Certificate of Good Standing;


WHEREAS, chapter mentors and honorary members are exempted to this policy;
